- 5. MOTION: Duly made (Propper), seconded and passed Admissions Committee revision of matriculation requirements in the School of General Studies as follows:

"Students in the School of General Studies may be considered for matriculation on the basis of work completed as a nonmatriculant in at least two divisions of the College when they have met one of the following criteria:

- A) 6 to 8 credits with a scholastic average of 4.00
- B) 9 to 11 credits with a scholastic average of 3.00
- C) 12 or more credits with a scholastic average of 2.00"
- 6. Committee on Committees:
  - a) MOTION: Duly made (Lieberman), seconded and passed:

"To add to the Individualized BA Programs Committee as an ex officio nonvoting member, the Director of the Individualized BA Program."

- 9. Return to consideration of Bylaws Committee Report:
  - a) Article VII, "Committees", Section 8, to be amended as follows after word "election" and before the word "All":

"An election shall be held as soon as practical to fill the balance of a term left vacant by resignation."

b) Article VII, Section 9, to be amended as follows - add sentence:

"Elections shall be held to fill the balance of terms as vacancies occur."

- c) Article VII, Sections 10 through 17 no amendments.
- d) Article VIII, "Amendments", Section 1 and 2 no amendments.
- e) Article IX, "Referendum", Section 1 no amendments.

  Section 2, amendment proposed by Burgess, to be amended as follows:

Insert word "annual" before the word "election" and add after "election" the words "of members of the Academic Senate."

f) Proposal (Nussdorf) to add to Article IX, Section 2, as follows:

"If a referendum is held concurrently with Academic Senate election, that referendum shall be considered binding."

- 13. Motion to adjourn meeting until two weeks from today April 29, at 3:00 p.m. Meeting adjourned at 4:45 p.m.
