

MINUTES OF THE ACADEMIC SENATE OF QUEENS COLLEGE - OCTOBER 21, 1971  
Academic II - Room 150

1. The Chairman, Eugene Fontinell, called the meeting to order at 3:25 p.m.

2. MOTION: Duly made (S. Axelrad), and seconded (Ferrari):

"To continue with unfinished business of the Graduate Curriculum Committee, on the agenda of October 14, regarding Resolution on 45 credit M.A. degree."

a) Friendly amendment (Wasserman) to 45 credit Resolution - add to No. 1, "c" to read as follows:

"The Queens College Master of Arts degree will be awarded only on the recommendation of the appropriate Queens College department."

b) Amendment (Gillman) add to 1-a of Resolution, after "doctoral program" the following:

"and who are taking courses at Queens College"

c) Chair ruled Gillman's amendment out of order.

d) MOTION: Duly made (Donenfeld) and failed - due to lack of second:

"To table Motion on 45 credit M.A. degree Resolution."

e) MOTION: Duly made, seconded and passed:

"To close off debate."

f) MOTION: Duly made, seconded and failed:

"Resolution on 45 credit M.A. degree."

3. (Sleeper) Proposed Amendments to the Charter of the University Faculty Senate. First page - underlined material.

a) MOTION: Duly made (E. Newman), and seconded (J. Donenfeld):

"To accept amendments to charter."

Forbes Hill - Article I, Section 2-a: "responsibilities"

Edgar Pauk - Amendment to strike out "responsibilities."

Chair ruled Pauk out of order - "document must be approved or disapproved in toto."

b) MOTION: Duly made, seconded and passed:

"To close off debate."

c) MOTION: Duly made, seconded and passed:

"To adopt in toto, Proposed Amendments to the Charter of the University Faculty Senate."

d) MOTION: Duly made (Pauk), and failed:

"To reconsider."

4. MOTION: Duly made (Warren), and seconded - Resolution on Military Recruitment:

"Recruitment by all branches of the American Armed Services on the Queens College campus shall be forbidden."

a) MOTION: Duly made (Fields), seconded and passed:

"To close off debate on Warren's Resolution."

b) MOTION: Duly made (Syrett), seconded and passed:

"To have a roll-call vote on Warren's Resolution."

c) Warren's Resolution fails - Roll-call vote:

44 Against - 43 For (see attachment).

5. New Business -

MOTION: Duly made (Rosenfeld) - Resolution as follows:

"The Academic Senate of Queens College having rejected, as contrary to the best interests of the student body, a proposal to ban all recruitment on the Queens College campus, and having rejected as discriminatory and undemocratic a proposal to selectively prohibit certain types of recruitment, expresses herewith its abhorrence of the concept that Queens College students may accept employment in capacities which do not permit them to serve humanity, but which result in harm to or destruction of human life and human values. We call on all students to carefully evaluate any employment opportunity available to them and to reject it if it does not meet the test of being socially productive."

a) Miksic offered friendly amendment:

"All organizations wishing to recruit will be required, if requested, to participate in an open session at the College, and answer questions with respect to the nature and operations of that organization. The specific procedures are to be worked out by the Campus Life Committee and the Recruiting Office."

b) Chair ruled friendly amendment is not germane.

6. MOTION: Duly made (Syrett), seconded and passed:

"To adjourn."
