# MINUTES OF THE ACADEMIC SENATE OF QUEENS COLLEGE - APRIL 27, 1972 Queens College Theatre

- 1. The Deputy Chairman, Dave Fields, called the meeting to order at 3:40 p.m.
- 2. MOTION: Duly made (Fontinell), seconded (Feuer), and passed:

"To suspend rules to consider resolution by Fontinell, Murphy, Friedman and Mittelman, for a Queens College Moratorium Day Coordinating Committee."

#### "WHEREAS:

The President of the United States is pursuing a policy of military escalation in Southeast Asia

#### WHEREAS:

The prolonging of this war is antithetical to the best interests of humanity;

#### BE IT RESOLVED

That the Academic Senate immediately establish a committee whose duties will be to devise ways by which this academic community can join with the Greater Queens Community to voice its opposition to the war in Viet Nam; and to join its forces with those in the Greater Queens Community presently organizing as part of the National Moratorium Day action on May 4th.

Of course, no student or faculty member will be obliged to take part in any Moratorium Day activities. However, the Senate expects that students who choose to participate will in no way be penalized and faculty who choose to participate will arrange to make up their classes at the first feasible opportunity."

Amendment (Stemple): To be added after last sentence - "Further, no teacher wishing to conduct classes, and no student wishing to attend classes, will be prevented from doing so."
