

MINUTES OF THE ACADEMIC SENATE OF QUEENS COLLEGE - January 4, 1973
Academic II - Room 150

1. The Deputy Holder of the Chair, Dave Fields, called the meeting to order at 4:00 p.m.

2. a) MOTION: Duly made (Schwerner), seconded and passed:

"To suspend the rules to introduce statement and resolution on Malcolm X Commemoration Day."

b) MOTION: Duly made (Schwerner), and seconded:

"The Academic Senate of Queens College respectfully requests the President and the Board of Higher Education to declare every February 22, Malcolm X Commemoration Day, a College holiday."

c) MOTION: Duly made, seconded and passed:

"To close off debate."

d) Livote's request for roll-call vote - failed.

e) Schwerner motion - passed.

3. The Holder of the Chair, Stephen Schwerner, assumed the Chair.

4. a) MOTION: Duly made (Warren), seconded and passed:

"To suspend the rules to take up resolution on escalation of the war in Vietnam."

b) MOTION: Duly made (Warren), and seconded:

"To accept resolution (by Warren, Litwak) as follows:

"We, the members of the Queens College Academic Senate, strongly condemn the recent escalation of the war in Vietnam and endorse the January 20, antiwar march on Washington, D. C. demanding - "Stop the Bombing - End the War Now!" Furthermore, we urge all students and faculty to support and participate in this protest."

c) Friendly amendment (Fields) - "To add the following:

"That the Queens College Academic Senate requests the Executive Committee to send a letter to every Congressman and Senator of the United States to vote to stop the funds for the war."

Warren accepted friendly amendment.

4. Warren, Litwak resolution (continued)

MOTION: Duly made, seconded and passed:

"To close off debate."

Warren, Litwak motion, as amended - passed.

5. Continuing with Article III, Section III-C.

MOTION: Duly made, seconded and passed:

"To accept Article III, Section III-C."

6. Article III, Section III-D.

a) MOTION: Duly made (Pierce), and seconded (Goodman):

"To delete from line seven, starting with 'The Division' through line fifteen, ending with 'Special Studies and Honors'."

b) Friendly amendment (Miksic) - "To add on line seven, after words 'to requisition' the words 'with the approval of the departmental chairperson'"

Pierce and Goodman accepted Miksic's friendly amendment.

7. (S. Axelrad) requested quorum call. There was no quorum.
