- c) Friendly amendment (Waterbury) To add as last sentence of Alsop's motion "As soon as possible, the President and Mr. Robbins should come before the Senate and explain his actions."
- d) MOTION: Duly made (Syrett), seconded and passed:

"To close off debate."

Request for roll-call vote - failed.

Alsop's motion, as amended - passed.

"To suspend rules to take up motion for administration to destroy all ethnic questionnaire cards kept on file, from previous years."

11. MOTION: Duly made (Fields), and seconded:

"Evaluation cards from Fall 1971 be destroyed during intersession between Fall 1972 and Spring 1973."

MOTION: Duly made, seconded and passed:

"To close off debate."

Field's motion - passed.

"To make all Holders of the Chair of standing committees of the Academic Senate, ex officio nonvoting members of the Academic Senate."
