  - b) Reichardt withdrew amendment.
  - c) MOTION: Duly made, seconded and passed:
 

"To accept Section VIII."

MOTION: Duly made, seconded and passed:

"To accept Section IX."
6. a) MOTION: Duly made (Fass), seconded and passed:
 

"To accept substitute for Article IV, Section V-A, as follows:

"The departmental chairperson for the School of General Studies, (if not already a member of the departmental P & B) shall only attend P & B meetings and have a vote when SGS personnel are under discussion."

  - b) MOTION: Duly made (Warren), and seconded:
 

"To delete Section V-A."

Chair ruled motion out of order.

## c) MOTION: Duly made, seconded and failed:

"To accept Fass' substitute for Section V-A, as main motion."

## 7. a) MOTION: Duly made (Fass), and seconded:

"To reconsider Reuder's amendment to Article IV, Section IV-A,  
as follows:

"In addition, however, any adjunct faculty who have had five  
or more years of continuously reappointed service, shall have  
one-half vote in the election of a chairperson."

## b) MOTION: Duly made (Syrett), seconded and passed:

"To close off debate."

Fass' motion "To reconsider" - passed.

## c) MOTION: Duly made (Mandel), seconded and passed:

"To close off debate on Reuder amendment."

Reuder amendment - failed.

## 8. a) Amendment (Muehsam) to Article IV, Section VII - "To add the words, "academic and" before the word 'ancillary'."

MOTION: Duly made (Reichardt), seconded and passed:

"To close off debate."

Muehsam amendment - passed.

## b) Amendment (Alsop) - "To delete the words, 'academic and ancillary' from Section VII."

## c) Amendment (Reichardt) - "To insert words, "full range of academic and all services" in Section VII."

Chair ruled Reichardt amendment out of order.

## d) MOTION: Duly made (Muehsam), seconded and passed:

"To close off debate on Alsop's amendment."

Alsop's amendment - failed.

"To suspend rules to consider immediately, the ethnic questionnaires being distributed presently during registration."

## b) MOTION: Duly made (Alsop), and seconded:

"Once again, the Academic Senate condemns the President of the College for allowing the ethnic questionnaires to be distributed to the students without first having shown the questionnaire to the Senate."

## c) Amendment (Marden) - "To add to Alsop's motion - a notice indicating that the questionnaire is abolished - should be placed immediately at the registration table."

Alsop did not accept amendment.

## MOTION: Duly made (Holford), seconded and passed:

"To close off debate."

Alsop's motion - passed.

## d) MOTION: Duly made (Mandel), and seconded:

"The Senate requests that the cards be impounded immediately, until such time as the President appears to explain the distribution to the Academic Senate."

## MOTION: Duly made (Holford), seconded and passed:

"To close off debate."

Mandel motion - passed.

"To return to the order of the day."

## MOTION: Duly made (Holford), seconded and passed:

"To postpone Article XIII until after Article IX of the Instructional Staff Procedures report is heard."

"To close off debate."

"To accept Appendix of the Commission Report."

"To accept addition to Appendix - Section IV-A and B, as distributed today." (see attachment)
