2. MOTION: Duly made (Chapline), seconded and passed:

"To suspend rules to consider items from Committee on Committees."

MOTION: Duly made, seconded and passed:

"That the Secretary cast one ballot for the slate submitted."

3. MOTION: Duly made (Warren), seconded and passed:

"To suspend rules to present resolution on tenure."

MOTION: Duly made (Warren), seconded and passed:

"That the Academic Senate invite President Murphy to appear before us at the November 8, 1973, meeting in order to explain the new tenure rules."

4. MOTION: Duly made (Hevesi), seconded and passed:

"To suspend rules to introduce resolution regarding incident at the College last Thursday."

MOTION: Duly made (Hevesi), and seconded:

"Resolved: That the Academic Senate of Queens College in deploring violence of any kind, condemns the actions of those students and guests of Queens College who instigated and participated in the disruption of the meeting last Thursday, October 25, 1973, at which Dr. M. T. Mehdi was the guest speaker and who participated in the violence that followed the meeting, and be it further

Resolved: That the administration of Queens College take whatever steps are necessary to inform members of the College community and guests of the College that persons behaving in such a destructive manner will be punished in accordance with the regulations governing the campus and the criminal law of the State of New York."

e) Page one, Section 1.2 - "To delete words, 'Support departments shall follow these structures and procedures excepting that they are exempt from the requirements of student participation (see Section 1.4)'."

Greener withdraws amendment.

6. Amendment (Newman), and seconded (Finkelstein) - "To delete Section 1.3, 'Definition of Voting Faculty'."

Newman and Finkelstein withdraw amendment.

7. a) Amendment (Dill) to Section 1.3 - "To place a period after words, 'full-time service.', and delete rest of sentence."

b) MOTION: Duly made (Stemple), and seconded:

"To postpone consideration of Section 1.3."

c) MOTION: Duly made (Mandel), and seconded:

"To suspend rules to consider Section 6.6."

d) MOTION: Duly made (Rothbard), and seconded:

"To recess for two minutes to read Section 6.6."
