Students: one Day, one SGS, one SEEK, one Graduate.

Faculty: two tenured, two nontenured."

"Resolved: That the Academic Senate of Queens College endorse the actions taken by the University Faculty Senate at its November 20, 1973, meeting, namely:

Be it resolved: That the University Faculty Senate declares its lack of confidence in Chancellor Kibbee because of his insistence on the adoption of this tenure policy; and

Further: That the University Faculty Senate urges the Board of Higher Education to suspend the implementation of, and to revoke the October 29, policy; and

Further: That the University Faculty Senate respectfully requests that Mayor-elect Beame and Governor Rockefeller not appoint present Board members to the new Board of Higher Education if they voted for the October 29, 1973 tenure policy, and that they appoint no new persons to the Board unless they indicate that they would vote to rescind the October 29, 1973 tenure policy."

"Be it resolved: That in view of the Soviet Union's policy of anti-semitism, suppression of other minorities and dissidents, we of the Academic Senate of Queens College condemn the Pepsico Company for its decision to trade with the U.S.S.R., and hereby ban the sale of all Pepsico products on the Queens College campus."

Be it further resolved: That upon enactment of this resolution by the Queens College Academic Senate, a copy of the resolution be sent to the Board of Higher Education."
