- 5. Special Motions
 - a) MOTION: Duly made (Gorkin), and seconded:
 - "Whereas, University Student Senate, Professional Staff Congress, Union of University Professors and Student Association of State Universities have called for a statewide rally to protest cuts in higher education budgets for Tuesday, March 16, 1976;
 - Whereas, the Queens College Student Association is offering free buses to this rally;
 - Be it resolved, that the Senate recommends no exams be scheduled either for Tuesday, March 16, or Wednesday, March 17;
 - Be it resolved, that no student be penalized for missing class on the 16th;
 - Be it further resolved, that the President of the College communicate this to the faculty."
 - Editorial changes: Paragraph three add words, "the Senate recommends" after 'Be it resolved'. Also add, the date of March '16' after the word, 'Tuesday'.

Resolution - passed, as amended.

- b) MOTION: Duly made (Haney), and seconded: (to adopt the following resolution):
 - "Whereas, the Chancellor of the City University of New York, in assigning a basic Liberal Arts mission to Queens College, has specified certain academic subjects as the "core" of the Liberal Arts and certain others as "peripheral", and
 - Whereas, the Academic Senate of Queens College, having the duly constituted authority and responsibility for determining the curriculum and the administrative arrangements for offering courses of instruction pertaining to the curriculum, and
 - Whereas, the variety of academic offerings which comprise the study of the Liberal Arts at Queens College does not correspond to the list of subjects specified by the Chancellor, by reason of combining certain of these subjects into a single department, by establishing portions of the covered fields into separate departments, or providing for a more comprehensive approach to the Liberal Arts through additional departments,
 - Be it resolved, that the Academic Senate of Queens College does not accept the validity of the listing or categorizing of subjects proposed by the Chancellor, and proposes instead that the designation of scope and composition of courses of instruction in the Liberal Arts remain the responsiblity of the duly constituted academic body of the college, and that any

movement toward consolidation of courses of instruction here with corresponding Liberal Arts offerings at other senior colleges of the City University be based upon (1) the academic quality of the programs at the units involved, and (2) the economic vitality of the programs based on student enrollment in relation to allocated resources;

Be it further resolved, that similar criteria apply to professionally oriented undergraduate and graduate academic programs."

Amendment (Bigman) - "To add the following: Be it further resolved, that the Academic Senate reject the proposals for the restructuring of the University, known as the "Kibbee Plan."

Seeing no debate, Chair called for an immediate vote.

Bigman amendment - failed.

Friendly amendment (Mell) - "To delete the following in the paragraph of, 'Be it resolved that': 'and proposes instead that' and add the word "since" after Chancellor. Delete everything after the word, 'college'."

Haney accepted Mell's friendly amendment.

Amendment (Neurath) - "To add the word "must" before the word, 'remain'."

Seeing no further debate, Chair meoved to an immediate vote.

Haney's resolution, as amended - passed by acclamation.

6. MOTION: Duly made (Bigman), seconded and failed:

"To modify agenda and place under Special Motions, resolution regarding Kibbee's Plan."

MOTION: Duly made (Gorkin), seconded and failed:

"To modify agenda and interchange items six and seven on the agenda."

Upon implementation of the report on the Organization of the College, the membership shall be as follows:

Students: Not more than one <u>undergraduate</u> student from any academic school or division.

Upon change of status or graduation the seat in question will be declared vacant."

Upon change of status or graduation the seat in question will be declared vacant.

Upon implementation of the report on the Organization of the College, the membership shall be as follows:

Students: Not more than one <u>undergraduate</u> student from any one academic school or division.

Upon change of status or graduation the seat in question will be declared vacant.

Amendment (Mandelbaum) - "To delete the following words in both paragraphs:

"Upon change of status or graduation the seat in question will be declared vacant."

MOTION: Duly made (Gavil), seconded and passed:

"To call all previous questions."

Mandelbaum's amendment - passed.

Bylaw change to be the first item of business at next Senate meeting.

- 9. Returning to the Undergraduate Curriculum Committee proposal (Senate meetings of February 19, and 26, 1976). Basic Skills Requirements:
 - a) Gorkin withdrew his amendment (Senate meeting of February 26, 1976) as follows:
 - "A student at the recommendation of the instructor, with consultation of the chairman, may be required to take English 6.0."
 - b) Amendment (Kirsch) "To delete English 6.0 (including 6.1, 6.2, etc.) on line two of paragraph one."

MOTION: Duly made (Gavil), seconded and passed:

"To close off debate on Kirsch's amendment."

MOTION: Duly made (Greco), seconded and failed:

"To have a roll-call vote on Kirsch's amendment."

9. Undergraduate Curriculum Committee - Basic Skills Requirements (continued)

Kirsch's amendment - failed.

c) MOTION: Duly made (Fass), seconded and failed:

"To close off debate on amended proposal."

d) Amendment (Stemple) - "To add the following words after paragraph two of amended proposal, and after new paragraph three (Herhenov's amendment), as follows:

"However, a student may not receive credit for the course if notification of the exemption is received before the first day of classes."

MOTION: Duly made (Gorkin), seconded and passed:

"To close off debate."

Stemple's amendment - passed.

e) Amendment (Alsop) - "To add the following words in the fifth paragraph after the words, 'Basic Skills Requirements': "must be started during the freshman year and."

Secondary amendment (Alsop) - changed amendment to - "must be completed by the end of the sophomore year."

Alsop withdrew secondary amendment. Back to original Alsop amendment -

MOTION: Duly made (Hershenov), seconded and passed:

"To close off debate on Alsop's amendment."

MOTION: Duly made (Greco), seconded and failed:

"To have a roll-call vote on Alsop's amendment."

Alsop's amendment - passed.

f) Amendment (Gorkin) - "To add the following words to the second sentence in paragraph one after the word, 'English 1': "Students in need of further writing instruction upon the completion of English 1, will be recommended to take English 6. Students who upon the recommendation choose to enter English 6, will be tested upon the completion of the course. These tests will be compared to similar tests administered to students completing English 1. The results of these tests will be reported to the Academic Senate after two semesters of testing in order to establish the validity for further writing requirements beyond English 1."

(Neurath) requested to move Gorkin's amendment - out of order.

Chair ruled Gorkin's amendment - in order

Neurath appealed the ruling of the Chair. Chair was upheld.

Gorkin's amendment - failed.

9. f) Undergraduate Curriculum Committee - Basic Skills Requirements (continued) MOTION: Duly made (L. Hill), seconded and passed:
"To close off debate on Gorkin's amendment."

 "To amend agenda and take up resolution on grade cards."
