b) MOTION: Duly made, seconded and passed:

"To adopt minutes of March 25, April 8, April 22, May 13, and June 21, 1976, as distributed."

Editorial change: minutes of April 22, 1976, room number should read A-170, instead of A-1207.

4. Announcements, Administrative Reports, and Memorials -

Dave Fields informed the Senate that the Board of Higher Education approved the Queens College Basic Skills Requirements and Distributional Requirements, passed by the Senate.

5. Special Motions -

MOTION: Duly made (S. Schwartz), seconded and passed:

"That the Executive Committee of the Academic Senate be charged with the responsibility of gathering information, studying and reviewing this information in terms of the impact of enrollment trends and budgetary projections on needs for political action, and further, to report to the Senate findings and recommendations monthly."

"To adopt Bylaw change made by the Executive Committee to the duties and composition of the Foreign Student Affairs Committee, as follows:

 in matters pertaining to foreign students."

 - iii. June 15, 1976, adopted a policy for those students who were unable to take final examinations in Spring 1976.
 - iv. July 20, 1976, adopted Interpretation and Planned Implementation of BHE Retention Standards, enclosed with Senate's agenda for October 14, 1976.
 - v. September 9, 1976, included the nontenured SEEK representation with the Department of Special Programs.

"To adjourn."

MOTION: Duly made (Mandelbaum), seconded and passed:

"To adopt minor changes in History, Music (editorial change from P/F to P/NC), Philosophy, Romance Languages, and Slavic Languages."
