"Be it resolved, that the Academic Senate of Queens College requests the Board of Higher Education to amend the Senate Charter by adding the following as a new Section XII:

In addition to those faculty members authorized by the Board of Higher Education Bylaws to vote in departmental elections for chairperson and for members of the departmental Personnel and Budget Committee, Lecturers with Certificates of Continuing Employment shall be extended these rights."

b) MOTION: Duly made (Held), seconded and passed:

"To postpone discussion until the regular March meeting."

IV. Undergraduate Curriculum Committee (Boylan) -

Returning to the Undergraduate Curriculum Committee proposals of December 1, 1978 (Academic Senate meeting January 11, 1979):

Consideration of the Interdisciplinary Major: Concentration in Business Studies -

a) Amendment: Duly made (Hechler), seconded and passed:

"To amend the proposal by adding to page 5, under the listing of optional electives, Mathematics 30, 31, or 51."

- b) Motion to adopt Concentration in Business Studies, as amended passed.
- 6. MOTION: Duly made (Lamacchia), seconded and failed:

"To amend the agenda to discuss the proposed tuition increase."

- 7. Returning to item 5-IV of these minutes Undergraduate Curriculum Committee (ditto sheet distributed today) New Course:
 - c) MOTION: Duly made (Boylan), seconded and passed:

"To adopt Spanish 87, E87 - Spanish and Latin American Cinema."

d) Amendment: Duly made (Alsop), seconded and passed:

"To amend the justification for Romance Languages courses - French 87. E87; Italian 87. E87; Spanish 87. E87; to read:

The Department of Romance Languages feels that the study of the (French) (Italian) (Spanish) cinema is a worthwhile area of investigation for those students interested in language, culture and literature. A course in this area would be a useful complement to existing classes in (French) (Italian) (Spanish)."

- 7. e) Vote on justification as amended, postponed until next item on the agenda is disposed of.
 - f) MOTION: Duly made (Alsop), seconded and passed:

"To refer to the Undergraduate Curriculum Committee for further consideration, Special Studies and Honors 97: The Irish in America."

- g) Returning to justification for Romance Language courses -Justification adopted without further amendment.
- h) MOTION: Duly made (Alsop), and seconded:

"To divide the question regarding Physics 60, E60."

There being no objection, the item under Physics was divided into a <u>Major</u> change for the adoption of Physics 60, E60, and a <u>Minor</u> change for the withdrawal, as follows:

MOTION: Duly made (Boylan), seconded and passed:

"To adopt Physics 60, E60: Introduction to Atomic and Nuclear Physics."

MOTION: Duly made (Boylan), seconded and passed:

"To withdraw Physics 60, E60: Atomic and Nuclear Physics for Engineers."

i) Undergraduate Curriculum Committee introduced its amended motion of December 15, 1978, on tutorials (as distributed today):

Amendment (Schwarcz) - "To add as a final paragraph, the following:

"Members of the Bylaw Instructional Staff not appointed through an academic department, but who possess appropriate academic training and credentials may also sponsor tutorials. Such tutorials must also be approved in writing by a Divisional Dean, the Dean of the School of General Studies, the Dean of Graduate Studies, the Dean of Teacher Education, the Provost, or the President as determined by the individual to whom the tutorial sponsor reports."

Amendment (Hershenov) - "To delete from the amendment by Schwarcz, the following: 'the Dean of the School of General Studies, the Dean of Graduate Studies'."
