## MINUTES OF THE ACADEMIC SENATE OF QUEENS COLLEGE - May 10, 1979 Academic II - room 170

- 1. The Holder of the Chair, Larry Mansfield, called the meeting to order at 3:45 p.m.
- 2. Approval of Agenda
  - a) MOTION: Duly made (Morton), seconded and passed:

"To amend the agenda and place under Committee Reports as item 5-a, Responsibilities and Duties of the Provost."

b) MOTION: Duly made (Vigliarolo), seconded and failed:

"To amend the agenda and place item 6 (Manas's motion regarding GPES courses 1-5), under item 4 - Special Motions."

c) MOTION: Duly made (Haney), seconded and passed:

"To amend the agenda and make item 5-d under Committee Reports, report of the Nominating Committee."

- d) Seeing no further amendments, the Chair called for vote on amended agenda. Agenda adopted - as amended.

MOTION: Duly made, seconded and passed:

Chair announced that the Senate's resolution on voting privileges for C.C.E.'s has been sent to the Council of Presidents, and that Deputy Chancellor Egon Brenner expects it will be some time before consideration is completed.

- e) Amendment (Mandelbaum) "In item 3-e, add the word, "and" after the words, 'Academic Senate', and delete the words, 'and the Professional Staff Congress'. Also add the word, "to" before the word, 'establish'."

Mandelbaum's amendment - passed.

f) Amendment (Hechler) - "To delete the last sentence of item 5, which reads: 'The stewardship of the Provost should be reviewed by the President every five years'."

Substitute amendment (Alsop) - "The stewardship of the Provost should be reviewed by the Academic Senate every four years."

Hechler withdrew his amendment.
