

MINUTES OF THE ACADEMIC SENATE OF QUEENS COLLEGE - November 15, 1979
Academic II - room 170

1. The Holder of the Chair, David Alsop, called the meeting to order at 3:40 p.m. In the absence of Dave Fields, Larry Mansfield served as Parliamentarian pro tempore.
2. Chair announced that the Undergraduate Curriculum Committee will continue with open hearings on proposed changes of curriculum requirements from 6:00 to 7:00 p.m. tonight in room A-170.
3. Continuing with the Agenda of November 1, 1979, item 5-c:

a) MOTION: Duly made (Mell), and seconded:

"To rescind Academic Senate approval of GPES (Graduate Programs in Educational Services) courses Nos. 1, 2, 3, and 4, passed in the Spring of 1979."

b) MOTION: Duly made (Lidstone), and seconded:

"To postpone discussion of the GPES courses until the first meeting of the Academic Senate in January 1980."

c) MOTION: Duly made (Khosrova), seconded and passed:

"To close off debate on motion 'to postpone'."

Lidstone's motion 'to postpone' - failed.

d) Ellie Schwartz, former student and Queens College graduate, requested permission to speak regarding GPES courses. Chair asked for unanimous consent, which was given.

e) MOTION: Duly made (Haney), and seconded:

"To postpone indefinitely Mell's motion 'to rescind'."

MOTION: Duly made (Pitchford), seconded and passed:

"To close off debate on Haney's motion."

Haney's motion - passed.

f) MOTION: Duly made (Fontinell), and seconded:

"To charge the Undergraduate Curriculum Committee to monitor and review GPES courses 1 through 5, and to report the result of their review, and any recommendations to the Academic Senate at its April 1980 meeting."

Amendment (Frisz) - "To add to Fontinell's motion the following:

"Further, the Committee shall arrange for a review of these courses to be conducted by outside consultants chosen by the Committee in consultation with the Department of Graduate Programs in Educational Services, and shall include this report with the Committee report when it is forwarded to the Academic Senate."

3. f) GPES courses 1 through 5 (continued)

MOTION: Duly made (LoRusso), seconded and passed:

"To close off debate on Frisz's amendment."

Frisz's amendment - passed.

g) MOTION: Duly made (Stemple), seconded and passed:

"To close off debate on Fontinell's motion, as amended."

Fontinell's motion, as amended - passed.

(Pitchford) request for quorum call. There was no quorum present.
