March 26, 1981

1. 3:45 p.m. No quorum.

MOTION: Duly made (Berger), seconded and passed:

"To wait 15 more minutes."

2. The Holder of the Chair, David Alsop, called the meeting to order at 3:50 p.m.

3. Undergraduate Curriculum Committee -

Continuation of discussion of the Institute of Applied Social Sciences (Academic Senate meetings February 26, 1981, and March 12, 1981):

- a) Eubank's amendment (on the floor) - "To delete the second sentence of item #1 under 'Degree Requirements for a Bachelor of Science in Applied Social Science'."

- b) MOTION: Duly made (Fields), seconded and passed:

"To close off debate on Eubank's amendment."

Eubank's amendment - failed.

- c) Amendment (Fontinell) - "To change the number of credits, in item 5-a, from 26 credits to 15 credits taken on Queens College campus."

Seeing no further debate on Fontinell's amendment, the Chair called for an immediate vote.

Fontinell's amendment - passed (24 to 21)

- d) Amendment (C. Cairns) - "To delete the paragraph on Language of Instruction."

Seeing no further debate on Cairns' amendment, the Chair called for an immediate vote.

Cairns' amendment - failed.

- e) Amendment (H. Greenfield) - "Under Core Requirements, to add to Economics 1 and 2, Economics 5, 13, and 14, making the total number of credits for Economics equal 15 credits."

MOTION: Duly made (Berger), seconded and passed:

"To close off debate on Greenfield's amendment."

Greenfield's amendment - passed.

- f) Amendment (H. Greenfield) - "Under 'Concentration in Administration and Delivery of Human Services', to add to #1, Economics 29."

Seeing no further debate, the Chair called for an immediate vote on Greenfield's amendment.

Greenfield's amendment - failed.

- g) Amendment (Mansfield) - "To delete items 1 through 6 listed under 'Concentration in Trade Union Administration'."

MOTION: Duly made (Krasner), seconded and passed:

"To close off debate on Mansfield's amendment."

Mansfield's amendment - passed.

- h) Amendment (Mansfield) - "To delete items 1 through 7 listed under 'Concentration in Administration and Delivery of Human Services'."

Seeing no further debate on Mansfield's amendment, the Chair called for an immediate vote.

Mansfield's amendment - passed.

- i) MOTION: Duly made (Krasner), and seconded:

"To add the words, "These rules become effective Fall 1981."

The Chair did not accept Krasner's motion, stating it was unnecessary, citing standing College policy.

- j) MOTION: Duly made (Krasner), and seconded:

"That the regulations passed by the Academic Senate in regard to the Institute of Applied Social Sciences apply only to those students who enter in September 1981 or after. Students currently enrolled shall be governed by the rules of the Program in force when they enter."

Substitute Motion (Speidel) - "To delete Krasner's motion and to add to the line, 'Degree Requirements for a Bachelor of Science in Applied Social Science', the words - "effective September 1981."

Krasner withdrew his motion.

Seeing no further debate on Speidel's motion, the Chair called for an immediate vote.

Speidel's motion - passed.

Be it resolved that, the Second Baccalaureate Degree Program requirements shall be amended to require "completion of at least 45 credits of Queens College courses ----."

II. MOTION: Duly made (Alsop), seconded and passed:

"Whereas, the English standards for Queens College state in part:

"students who, on the basis of their English Placement Examination, have been assigned to a course below the level of English 01 will be permitted to register for departmental courses only with the written approval of a CESL Academic Advisor." (January 10, 1980 Motion: page 21, IV-A: Academic Senate Policies 1970-1980), and

Whereas, the College offers non-second language English courses below the level of English 01 for SEEK students, and

Whereas, the SEEK Program has its own staff of Academic Advisors for the guidance of SEEK students, therefore

Be it resolved that, IV-A of the English Standards (page 21, Academic Senate Policies 1970-1980), shall be amended to read:

"IV. A. Students assigned to composition courses below the level of English 01 on the basis of their scores on an English Placement Examination will be permitted to register for departmental courses only as stipulated below:

- 1) Non-SEEK students assigned to CESL composition courses must have written approval from a CESL Academic Advisor.
- 2) SEEK students must have written approval from a SEEK Academic Advisor."

The Holder of the Chair, resumed the Chair.

Motion to adopt English courses 4.1 and 4.2 - passed.

b) MOTION: Duly made, and passed:

"To adopt minor changes in Chemistry, English 2 (formerly English 6), and change in description in General Psychology and Experimental Psychology."
