- l. The Holder of the Chair, Mary Reuder, called the meeting to order at 3:45 p.m.
- 2. President Cohen addressed the Academic Senate, and invited questions.
- 3. Approval of Agenda -

MOTION: Duly made (Nazerian), seconded and passed:

"To amend the agenda, and place under Special Motions for nominations to fill the vacant student S.G.S. seat (to 1985) on the Nominating Committee."

Seeing no further amendments, the agenda was adopted - as amended.

- 4. Announcements, Administrative Reports, and Memorials -
  - I. The Chair announced the following:
    - a) At the November 1, 1984, Academic Senate meeting there will be nominations and elections to the Search Committee for the Dean of School of Education, and nominations and elections to the Review Committee for the Dean of School of General Studies.

In accordance with the Standing Rules of the Academic Senate Bylaws, the composition of these committees shall consist of 5 faculty and 5 students: at least one faculty and one student from each academic division, and no more than one faculty and one student from any one department.

- b) At the <u>January 1985</u>, Academic Senate meeting there will be nominations and elections to the <u>Review Committee for Dean of Graduate Studies and Research</u>, and the <u>Review Committee</u> for Dean of Students.

The Advisory Committee will consist of at least four members, one each from the Departments of English, Classical and Oriental Languages, History, and Philosophy; appointed by the Dean of the School of General Studies, with the approval of the chairpersons of the various departments involved.

"To adopt proposed Catalog Description - THE MINOR (24 credits): Groups I, II, and III."

"To adopt new courses in Puerto Rican Studies: PRS 201, 202, 204, 208, 220, and 380."

Editorial Change (Speidel) - "To add the word, "THE" before the word 'Latin' in PRS course 208."

Course PRS 208 to read: THE PUERTO RICAN AND THE LATIN AMERICAN WOMAN.
