Be it resolved, that the Academic Senate of Queens College requests the administration to ban smoking in all hallways and stairwells where students and staff must pass to attend classes or carry on other business of the College, with the exception of well-defined isolated smoking sections, and

Be it further resolved, that the Academic Senate requests the administration to post signs in all such hallways and stairwells as well as in classrooms informing all as to why this action has been taken."
