d) Undergraduate Admission, External Course Work and Assessment Retention Standards Committee (Temsamani) -

MOTION: Duly made: (To adopt the following Fresh Start Policy):

"Whereas, the College has set basic minimum requirements for the admission of transfer students and non-degree students based on the grade point average attained in other college work, and

Whereas, early college achievement may not reflect some students' present abilities to complete college course work successfully, therefore

Be it resolved, that Queens College establish a "Fresh Start"
Policy whereby applicants to Queens College will be
considered for admission by the Undergraduate Admission,
External Course Work and Assessment Retention Standards
Committee.

To be considered for admission under the "Fresh Start" Policy, students must:

- have an academic record at another college which fails to meet the Queens College standards for transfer matriculation and admission to non-degree status; and
- 2. allow three years to elapse following the unsatisfactory academic performance in another college; and
- 3. be interviewed by a representaive of the Undergraduate Admission, External Course Work and Assessment Retenttion Standards Committee, and must demonstrate that:
 - a) their employment record or evidence of achievement now indicates good scholastic potential;
 and/or
 - b) a change in motivation and/or circumstance has occurred which is like ly to result in satisfactory academic performance, and
- Be it further resolved, that this Policy operate for three years beginning December 1, 1985, after which it will be reviewed by the Undergraduate Admission, External Course Work and Assessment Retention Standards Committee. The results of the review will be reported to the Academic Senate."

5. d) Undergraduate Admissions' Fresh Start Policy (continued)

Amendment (Mandelbaum) - "To change the words, 'three years' to "two years" in item 2."

Seeing no further debate on Mandelbaum's amendment, the Chair called for an immediate vote.

Mandelbaum's amendment - failed.

Editorial change - "In item 2, after the word 'elapase', change the word, 'following' to "between."

Amendment (Hechler/Speidel) - "In item 2, to add the following words after the word, 'college;': "and the applicants proposed first registration; and"

Seeing no further debate on Hechler/Speidel amendment, the Chair called for an immediate vote.

Hechler/Speidel amendment - passed.

Seeing no further debate on the Motion for a Fresh Start Policy, as amended, the Chair called for an immediate vote.

Fresh Start Policy, as amended - passed. (see attachment)

e) Executive Committee (Mansfield) -

MOTION: Duly made: (To adopt the following BYLAW change):

"Whereas, the implementation of the regular course and faculty evaluation process has been an extremely costly item for the College, amounting most recently to approximately \$17,000 for the Spring 1985 evaluation, and

Whereas, the current College budget is severely strained with little expectation of relief, and

Whereas, there has been limited apparent use by students of the results of these evaluations in recent years,

Be it resolved, that the charge to the Course and Faculty Evaluation Committee be amended as follows:

To supply this material to the Provost in sufficient time so that the questionnaire may be administered *every third semester /in the Spring and Fall semesters of the same odd-numbered calendar years/, and subsequently published by the College."
