"To establish the following policies concerning Graduate Division procedures for Appeals of Grades:

A student who believes that he or she has received an inappropriate grade should take the following steps:

- 1. Consult with the instructor.
- 2. If there has been no satisfactory resolution, consult with the department chairman. The chairman may convene a faculty committee to review the appeal.

5. IV. Graduate Scholastic Standards Committee proposal Appeals of Grades (continued)

- 3. If there is still no satisfactory resolution, appeal to the Dean of Graduate Studies and Research for a further review. The appeal must be in writing and must detail the reasons why the grade is felt to be inappropriate.
- 4. Appeals from the decision of the Dean may be directed in writing to the Graduate Scholastic Standards Committee.

The only grounds for an appeal to the Dean and the Scholastic Standards Committee are that the student has been treated in an arbitrary and capricious manner by the instructor. In order to make such an appeal, the student must be prepared to demonstrate that a grade has been assigned punitively, unfairly, or on a basis other than impartial academic evaluation. At the departmental level, however, a grade appeal may also be based on the academic quality of the student's work."

V. Campus Affairs Committee (Roze) -
