"To adopt change in Program in Urban Studies, to read:

The major in Urban Studies consists of 39 credits in courses from the Department of Urban Studies and closely related disciplines. Idt consists of the following:

- 1. Urban Studies 101.
- 2. Udrban Studies 200 (or equivalent).
- 3. 6 credits to be chosen from among Economics 101 (or 1), Political Science 102 and
 Sociology 101.
- 4. Either Urban Studies 360 or 370.
- 5. 24 credits of courses in Urban Studies which will be arranged by an advisor to give a concentration in a field of Urban Studies. Examples of such concentrations include Housing and City Planning, Health and Human Services, Ethnic Groups and Communication, etc. Sociology 205 or Sociology 222 may be included among the 24 credits if this is appropriate."

"To adopt minor change in credits and hours in course in Urban Studies; and course withdrawal of Urban Studies course No. 4 - Institutional and Social Change."

b) MOTION: Duly made:

"That the following three paragraphs of the original policy reading:

"Students with such palcement (i.e. at English 110 or above) who have not passed English 110 by the end of their freshman year, or English 120 by the end of the sophomore year shall be placed on probation and dismissed from the College at the end of the following (Spring or Fall) semesster if they have not passed the requisite course by that time.

Moreover, students who drop or withdraw, without permission of the Undergraduate Scholastic Standards Committee, from English 105 or lower level English courses will immediately be placed on probation and will be dismissed frm the College at the end of the following (Spring or Fall) semester if the requisite course has not been taken by that time.

Further, students who drop and/or withdraw, without permission of the Undergraduate Scholastic Standards Committee, from required courses in the English sequence more than once shall be liable to immediate dismissal for failure to maintain the mandated continuous registration; dismissal is mandatory for a third unauthorized drop and/or withdrawal.

BE REPLACED WITH:

The Queens College writing requirement (normally English 110 and 120 or its equivalent) must be completed before entrance to the upper division of the College (e.g. beyond 60 credits). Students failing to complete the writing requirement prior to completion of 60 credits will be required to follow a course of action set out by the College after review of the student's records to date. Continuous enrollment in the appropriate English course is a necessary condition for registration beyond the 60th credit for students who have not completed the English writing requirement and have maintained continuous enrollment in English writing courses. Students who have not maintained continuous enrollment in English writing courses may be limited to an English writing course until satisfactory completion of the College requirement."

"To refer this motion to the Undergraduate Scholastic Standards Committee, for discussion and perfection of the motion.

Friendly amendment (Frisz): "To add to Hechler/Mandelbaum motion, to be brought back to the Academic Senate at its May 1987 meeting.

Hechler/Mandelbaum accepted friendly amendment.

Amendment (Alsop), seconded (Speidel): "to amend Frisz's amendment by severing the date, May 1987."

Seeing no further debate on Alsop/Speidel amendment, the Chair called for an immediate vote.

Alsop/Speidel amendment - failed.
