- 'C. The Academic Senate shall meet regularly on the second Thursday of each month from October through May'. The January meeting of the Academic Senate shall be optional at the discretion of the Senate's Executive Committee."

"To amend Bylaws Article VII, Section 24-A, for the renaming of a Standing Committee, as follows:

"To repeal Article VII, Section 24-B-II of the Academic Senate Bylaws (Campus Beautification Committee).

"To adopt a new Article VII, Section 24D, of the Academic Senate Bylaws for the establishment of a Standing Committee, Campus Environment Committee, with the following duties and membership:

6. III. c) ii. Bylaws, Article VII, Section 24-D: <u>Campus Environment Committee</u> (continued)

## "1. Duties:

- a) To review, suggest and make recommendations on any aspect of life concerned with the campus grounds within the understanding that major reconstructions are an administrative duty. This is to include plantings, landscaping, and renovatons of buildings as it pertains to external areas, entrance foyers and/or lobby (e.g. color scheme and accessories selection).
- b) The Committee shall review proposals to name campus buildings and the creation of memorials and shall make its recommendations to the Academic Senate.
- Membership: eight voting, nine nonvoting
  - a) Faculty: one from each of three divisions, one at large.

Students: one from each of three divisions, one at large.

b) Ex officio nonvoting: Director of Campus Facilities

Director of Student Union

Director of Alumni Association

Designee of College President

Representative of Q.C. Retirees

Representative of Q.C. Women's Club

V.P. for Finance

V.P. for Student Affairs

Campus Horticulturist."

d) i. MOTION: Duly made, and passed:

"To amend Bylaws Article VII, Section 24-F, regarding ex officio membership, as follows:

- 'F. Curriculum Committee Undergraduate
  - 1. Duties: To make recommendations to the Academic Senate in all matters of undergraduate curriculum.
  - 2. Membership: eight voting, [one] two nonvoting.
    - a) Faculty: one from each of three divisions; one at large.
       Students: one from each of three divisions;

one at large.

b) Ex officio (nonvoting): Provost' Registrar or designee."

6. III. d) ii. MOTION: Duly made, and passed:

"To amend Bylaws Article VII, Section 24-G, regarding ex officio membership, as follows:

- 'G. Elections Committee
  - 1. Duties: As in Bylaws.
  - 2. Membership: 8 voting, [one] two nonvoting

e) MOTION: Duly made, and passed:

"To amend Bylaws Article VII, Section 24-I, as follows:

- 'I. Foreign Student Affairs Committee
  - 1. Duties:
    - a) To review policies pertaining to foreign students in all areas of academic life, and to make recommendations for changes in these policies to the Academic Senate.
    - b) To advise the Dean of Students in matters pertaining to foreign students.
  - 2. Membership: 8 voting, [one] three nonvoting.

6. III. f) i. MOTION: Duly made, and passed:

"To add to Section III of the Charter, item E, as follows:

- E. The Academic Senate may adopt bylaws regarding the removal from office of habitually absent Senators."
- ii. MOTION: Duly made, and passed:

"To add to Bylaws in Article VIII, a new Section 10, as follows:

#### Section 10

- a) When an Academic Senator misses four consecutive meetings the Holder of the Chair of the Academic Senate or any member of the constituency represented by that Senator may petition the Executive Committee, in writing, to declare that member's seat vacant.
- b) Before a faculty Senator goes on leave, the faculty

  Senator must give written notice to the Holder of the
  Chair of the Academic Senate as to whether the Senator
  intends to continue to serve. In the absence of written
  notice, if the Senator misses two meetings while on leave
  the Holder of the Chair of the Academic Senate or any
  member of the constituency represented by that Senator
  may petition the Executive Committee to declare that
  Senate seat vacant.
- c) The Secretary of the Academic Senate shall, upon receipt of the prescribed written petition to declare an Academic Senate seat vacant, immediately notify the Senator, in writing, that the Senate seat is in jeopardy of being declared vacant.
- d) The Senator shall have the right to appear before the Executive Committee to explain the absence, subject to the time limitation set forth in paragraph e.
- e) The Executive Committee shall, no sooner than one week nor later than one month after the original notification from the Holder of the Chair of the Academic Senate or a member of the constituency of the absent Senator, determine whether or not the seat should be declared vacant.
- f) If the Executive Committee votes to declare an Academic Senate seat vacant, the Senator shall have the right to appeal this decision to the Academic Senate for final determination. The issue of the vacant seat shall be placed as a special motion on the next regular Academic Senate agenda.

- 6. Bylaws Article VII, New Section 10 (continued)
  - g) A Senator whose seat has been declared vacant by the

    Executive Committee may not vote on the appeal of the

    Executive Committee's decision when it goes to the full

    Senate."
  - g) MOTION: Duly made, and passed:

"To adopt a new Standing Rule, as follows:

Nonmatriculated (nondegree) students may stand for election to Academic Senate Committees only in accordance with the following procedure:

- 1) All proposed nominations of nonmatriculated students must first be reviewed by the Academic Senate Nominating Committee before they may be made on the floor of the Senate.
- 2) The Nominating Committee may only consider the proposed nomination of a nonmatriculaated student if a majority of the Committee membership passes a resolution asserting that consideration of that student is in the best interests of Queens College.
- 3) The Nominating Committee shall, when making a nomination on the floor of the Senate ,advise the Senate that a proposed nominee is a nonmatriculated student.
- 4) A nonmatriculated student must have a minimum cumulative grade point average of 2.0 at the time of nomination."
