"Beginning with the Spring 1987 semester, Queens College shall apply the same standards of probation and retention for nondegree students as are applied to degree students with the exception of Senior Citizen nondegree students who are exempted."

b) MOTION: Duly made, and passed:

"The Queens College English language writing requirement (normally English 110 and 120 or their equivalent) must be completed before entrance to the upper division of the College, (i.e., registering beyond 60 credits). Students who fail to meet the College writing requirement within this 60 credit limit will have their registration limited to English writing courses until satisfactory completion of this requirement. Exceptions to this restriction can be granted only by the Undergraduate Scholastic Standards Committee.

Students admitted to advanced standing who have more than 60 credits and who have not satisfied the Queens College writing requirement must satisfy the English language writing requirement within the first two semesters in which they are enrolled at the College. Those who fail to do so will have their registration limited to English writing courses until satisfactory completion of this requirement. Exceptions to this restriction can be granted only by the Undergraduate Scholastic Standards Committee."

"To adopt the following amendment to CAP Standing Rules Article VII, Section 26:

NOTE: New material underlined; material in brackets to be deleted.

## "I. Criteria for Subsidization of Athletes (Grants in Aid):

1. CAP may award grant-in-aid to students who exhibit a high degree of athletic talent (as verified by the coaching staff), and also meet the academic requirements listed in Tier I or Tier II below. [Forty percent of each team's new grant-in-aid awards must meet Tier II standards.] At least forty percent of each team's awardees must meet Tier II standards.

i. Tier I. Eligibility consists of either admission (at time of award) through the normal admission process, or being a current Queens College student with a grade-point average of 2.0.

5. VI. CAP - Criteria for Subsidization of Athletes (continued)

ii. Tier II. Eligibility consists of either entering the College from high school with an average of 85 or above, or having 1100 on their SAT's, or being a current Queens College student with a grade-point average of 2.75 or above.

iii. All awards are for a maximum of four years regardless of the student's athletic performance. A student can lose his or her aid only by becoming academically ineligible."
