- iii. XVII. Subsidization of Athletes (Grants in Aid), add item H. to read as follows:

Grants-in Aid awards shall be limited to reimbusement for the following educational expenses: tuitition fees, books, meal allowance and transportation. The amount of each award shall be proposed by the Athletic Office, and approved by CAP for consistency with Title IX, and College and NCAA guidelines."

(BYLAWS).
