- 5. Announcements, Administrative Reports, and Memorials
 - a) Prof. Harvey Gram, Chair, Committee on Undergraduate Admissions and Re-entry Standards, addressed the Senate to emphasize the vacant faculty and student seats on the Committee.
 - b) Administrative Reports by the Chair:
 - i. Dr. Speidel announced that Elizabeth Constantinides (Classical & Oriental Languages) had died.
 - ii. Dr. Speidel gave a summary of what he had presented to the University Faculty Senate concerning the budget cuts at Queens College. He reiterated that President Kenny deserves "high marks" for hiring 12 new faculty.
 - iii. He spoke briefly about the 11th Hour Coalition.
 - iv. He spoke about Trustee Robert Pickens' testimony to the Board of Trustees concerning salary raises to Queens College administrators.

6. II. A. Undergraduate Curriculum Committee (Thurber) -

"To adopt the revised page of proposal dated March 19, 1992, as distributed, TO READ:

'Students who want to major in economics <u>must take Mathematics 21 or the equivalent and</u> must select at least 30 credits in economics courses exclusive of courses numbered 151, 253, 254, 258, and 370. Econmics 101, 102, 205, 206, and 249 <u>and 382</u> are required of all majors. Transfer students must take at least 15 hours of economics at Queens College. All students must have at least a C average for the economics courses taken at Queens College and, in addition, a C average in the required courses in economics'."

 - WHEREAS, postcards are verifications for the students of grades received by the Registrar, and
 - WHEREAS, not accepting postcards works to the detriment of students who need their current indices for financial aid applications, and
 - WHEREAS, such refusal causes undue hardship for student waiting for grades, therefore
 - BE IT RESOLVED, that the Academic Senate request all faculty members to accept postcards from students, and use them to mail grades in a timely fashion."
 - b) Amendment (Alsop) "In the paragraph 'Be it Resolved' delete the words, 'that the Academic Senate request' and replace the word 'to' with the word, "shall" before the word, 'accept'."
 - c) Editorial clarification (Lord) "To add the words: stamped, selfaddressed before the word, 'postcards'.

Alsop accepted the editorial change.

- e) Motion as amended passed.
