- Whereas, the students of Queens College are required to meet the financial obligations of the facility through the student activities fee;
- Whereas, the Queens College Student Union has been forced to cut drastically student programming, personnel, and services, and as a result finds itself unable to meet its obligation to the Queens College community;
- Whereas, the students of Queens College are forced to pay the highest student activity fee in the entire University;
- Whereas, the fiscal crisis has undermined the very nature of the Queens College Student Union by cutting the very heart of the program; and
- Whereas, the students of Queens College are the ONLY students within the City University of New York system required to meet the bond requirement burden; now therefore
- Be it Resolved, that the Academic Senate of Queens College requests that the State of New York, through its elected representatives, provide relief for the students of Queens College from the unfair burden of financing the Student Union Building which is not required by any other CUNY students."
