II. Graduate Scholastic Standards Committee (Wochinger) -

MOTION: Duly made, and passed:

"To adopt the following resolution:

- Be it resolved, that graduate students may withdraw from courses without evaluation during the fourth through the eighth week of the semester, such time frame to be consistent with that for undergraduate withdrawals, and that such withdrawals are to be selected using the telephone registration system and
- Be it further resolved, that from the ninth through the thirteenth week the current "Permission for a Graduate Student to Withdraw from a Course" form, which requires the signatures both of the instructor and the graduate advisor be used, and
- Be it further resolved, that commencing with the fourteenth week the current policy of using the form and requiring the additional approval of the Assistant to the Provost for Graduate Studies be retained, and

"Be it further resolved, that this policy shall go into effect for the Fall semester 1995."

- III. Undergraduate Scholastic Standards Committee (K. Ritchie)
 - a) MOTION: Duly made:

"Be it resolved, that beginning with the Spring semester of 1995, Queens College shall conform to The City University of New York Repeat Course Policy."

The Executive Committee divided the Resolution into three separate Motions, as follows:

- 1. Queens College shall conform to the CUNY 16 credit limit for the Repeat Course Policy.
- 2. Queens College shall limit the replacement of grades to original grades of "F" or administrative F's.
- 3. Queens College shall limit the grades that can be used to replace original grades to grades of "C" or better.

Executive Committee Motion No. 1: 16 credit limit

b) Substitute Motion (S. Ramchand) -

"Be it resolved, that beginning with Fall semester of 1995, Queens College shall conform to the following Repeat Course Policy outlined below:

A student may only repeat an individual course once to replace that course grade in his/her Grade Point Average. In this event, any grade received from this repetition supersedes the original grade. A subsequent repetition of that course shall only appear on the student's transcript but shall have no impact on his/her Grade Point Average. A student may only freely exercise this option up to sixteen credits. Any further repetition would require that the student consult with an advisor, who will counsel him/her on the consequences of the repetition."

c) Amendment (K. Lord) - "to delete the words, in the last sentence:

'the student consult with an advisor who will counsel him/her on the consequences of the repetition' and substitute with the words: "receive the permission of the Undergraduate Scholastic Standards Committee."

"To close off debate on the amendment to the Substitute Motion."
