November 14, 1996

The Holder of the Chair, Joel Mandelbaum, called the meeting to order at 3:50 p.m.

# 2. Approval of Agenda:

MOTION: Duly made (Birth), seconded, and passed:

# 4. Announcements, Administrative Reports, and Memorials:

- a. The Chair welcomed the large number of visitors. He encouraged them to become members of the Senate and/or committees.
- b. The Chair requested volunteers for the LASAR committees that are being formed. There are two faculty openings for the University Faculty Senate. There is one faculty opening on the Presidential Committee on Academic Priorities.
- c. Senator de Luise (Chair Campus Affairs Committee) reported on the CUNYcard which would replace the current ID card and library card and have additional options.
- d. Dave Fields (Chair Special Committee on Governance) stated there was available on the front desk a proposal for expanding alternate seating in the Senate.
- e. A Memorial Statement for Suzanne Katz (formerly of the Library) who died on November 1, 1996 was read by Manny Sanudo.

The Academic Senate paid its respects by rising for a moment of silence.

f. Announcement of the death of Mike Hall (Linguistics) who died on November 11, 1996 was made by Helen Cairns.

g. Senator Lord announced there will be a CUNY-wide conference held on Friday, December 6, 1996 on the CUNY ICAM policy, which is a report that came out in response to Resolution 25 of the 39 Points of Light. This report dealt with the ability of CUNY students to take courses at alternate campuses of the University.

#### Classical, Middle Eastern and Asian Languages and Cultures, to read:

352. Modern Hebrew Poetry.

3 hr. 3 cr.; Prereq: Hebrew 305

Varied readings set within a broad literary, social, historical and political context that takes into account the traditional Jewish, European and Middle Eastern influences affecting the formation of contemporary Hebrew poetry. May be repeated for credit provided the topic is different.

356. Contemporary Israeli Literature.

3 hr.; 3 cr. Prereq: Hebrew 305.

Readings may include poetry, prose, short stories, novels and essays reflecting the complex dynamic that has gone into the formation of contemporary Israeli culture. May be repeated for credit provided the topic is different.

Aaron Copland School of Music: Page 167 of the 1995-96 Queens College Undergraduate Bulletin, to read:

3. The Music Major with the Music Education Sequence Students who intend to teach music in public schools or other institutions requiring State certification must take all of the courses listed in section 1 above except Music 373, plus Secondary Education 201, 221, 222, 267, and 377 and Music 166, 268 (or 269), and 370. They are required to select a concentration in either instrumental or choral music education. required instrumental sequence includes Music 161, 162, 163 (or 164), 167, and 168. Guitarists and pianists wishing to enter the instrumental sequence must meet special requirements and should consult the Music Student Handbook available from the departmental office. The required choral sequence includes Music 265, required for those whose keyboard skills are found upon examination to be less than adequate, and Music 266. Further, choral students must choose either Music 276 or 378 from section 1 above. Those who want to obtain the broadest possible professional preparation may elect to take both the instrumental and choral sequences if their total credits for graduation fall within the specified limit established by the College.

Bachelor of Music students may not enroll in the education sequences undergraduates. Those wishing to obtain State teacher certification must complete their undergraduate degree and may then apply for the Advanced Certification Program in Music Education (see the current Graduate Bulletin).

Standards for admission to student teaching:

a. A minimum grade-point average is 2.7 in music major courses exclusive of electives, performance and ensemble courses....

### Department of Chemistry and Biochemistry

#### New courses:

Chemistry 386. Physical Methods of Structure Determination.

3 lec. hr.; 3 cr. Prereq: Chemistry 252.

A survey of the main methods for determining the structures of compounds from physical measurements. Interpretation of data from infrared, mass, and nuclear magnetic resonance spectrometry, including the use of two dimensional techniques. Discussion of other physical methods such as x-ray diffraction and visible-ultraviolet spectroscopy.

### 5.b. Undergraduate Curriculum Committee (continued):

Chemistry 387. Advanced Integrated Laboratory and Introduction to Research Techniques.

1 hr. rec.; 5 lab. hr.; 3 cr. Prereq or coreq.: Chemistry 331, Chemistry 386, and either Chemistry 362 or Chemistry 378.

The synthesis, separation, and characterization of both inorganic and organic substances using advanced laboratory techniques such as syringe procedures for working in air-free systems, vacuum distillation and sublimation, use of liquid ammonia, chromatographic techniques of separation, and soxhlet extraction. Hands-on use of Fourier transform infrared and nuclear magnetic resonance spectrometers, and use of circular dichroism and fluoescence equipment.

"To amend the statement on absence as passed at the February 15, 1996 Academic Senate meeting, and add the clause 'Although absence in and of itself shall not affect a student's grade,'.

'By registering in a course, the student assumes the obligation to fulfill the requirements set for that course by its instructor. Although absence in and of itself shall not affect a student's grade, students are responsible for such activities as participation in class discussions, laboratory sessions, field trips, etc.; the preparation of papers and reports; and the taking of quizzes and examinations, any or all of which may constitute a component in the student's final grade for the course. In addition to observing the regulation regarding withdrawal from a course, students are expected as a normal courtesy to inform the instructor of prolonged absence or withdrawal.'"

b. Intra-CUNY Academic Mobility (ICAM) Policy:

MOTION: Duly made (Frisz), seconded, and passed:

"Both the Executive Committee of the College Personnel & Budget Committee and the Executive Committee of the Academic Senate meet to draft a motion regarding the ICAM policy which could be presented to both the Academic Senate and the College P&B for action."
