

If you have checked the Retention Standards and Academic Probation Information on the USSC website and have determined that you are on probation, you should be aware of the possible outcomes at the end of the spring term regarding your status, beginning with the immediately following fall term.

All updates to student records should be complete by mid-June. Please check your official record after that time at https://home.cunyfirst.cuny.edu/oam/Portal_Login1.html to determine your academic status.

1. If your cumulative GPA is 2.00 or higher, you will be automatically assigned "Good Standing". You may register for summer sessions and a maximum of 18 credits for regular semesters.

~OR~

2. If you completed all spring courses with earned grades of A+ to F (with no INC, PEN, or WU grades) and your spring term GPA is 2.25 or greater, but your cumulative GPA is still below 2.00, you will automatically be assigned "Extended Probation" status for the fall term. You may register for summer sessions and a maximum of 13 credits during regular terms while on probation.

~OR~

3. If you were on Regular, Extended or Reentry Probation for the spring term and received "W" grades for all of your spring term classes, you will automatically be assigned "Extended Probation" status for the fall term. You may register for summer sessions and a maximum of 13 credits during regular terms while on probation.

~OR~

4. If you were on Continuing Probation for the spring term (did not meet probation requirements at the end of the previous fall term) and received "W" grades for all of your spring term classes, you may not register for the following summer sessions or

following fall term, but may apply for reentry for the next spring term. Reentry information and applications may be obtained at http://www.qc.cuny.edu/admissions/undergraduate/reentry/Pages/Welcome.aspx

5. If your spring term GPA is less than 2.25 and your cumulative GPA is still below 2.00, you will be academically dismissed, with opportunity to appeal for reinstatement. You may register for summer sessions; however, if registered for the fall term, all classes will be cancelled.

If your appeal for reinstatement to the USSC is approved, you will be permitted to register or re-register for the fall term. Notices of academic dismissal, with enclosed appeal forms, will be sent to students, usually by the end of June via QC webmail. If you have not yet set up your QC webmail, you may do so at http://www.gc.cuny.edu/StudentLife/services/online/Pages/WebMail.aspx

If you do not receive a USSC academic dismissal notice, with appeal, by July 1st, IMMEDIATELY call the USSC office at (718) 997-4486 for assistance. All USSC decisions of appeals for reinstatement will be sent to students via QC webmail ONLY. Decisions by the USSC on appeals of academic dismissal are final.

<u>Please note</u>: All students are responsible for determining their academic status, reading their Q.C. webmail and if academically dismissed, submitting their appeal for reinstatement after an academic dismissal to the USSC by the mid-July deadline indicated on the appeal for reinstatement. No excuses or exceptions!
