

REGISTRATION

Student-parents register their children according to their class schedule, with priority given to current center parents. Each child is scheduled on a consistent basis for the entire semester since the center does not provide drop-in or babysitting services.

Evening session is provided for school aged children from 3 p.m. to 8 p.m. Arrivals are scheduled on an hourly basis beginning at 3 p.m. with a minimum requirement of two hours daily and four hours weekly. The evening rates will apply to any child scheduled to arrive at 3 p.m. or later.

A registration session for new applicants is scheduled prior to each semester. Enrollment is on a first-come first served basis, and registration in any time period will close when all available spaces are filled. A non-refundable registration fee must be paid at the time of registration.

TUITION

Fees are based upon the number of hours a child is registered in the center each day. A weekly fee is determined and total tuition is calculated on a sixteen-week basis for Fall and Spring semesters. All fees are subsidized; further subsidies may be available to eligible families.

The After School Program provides a quality after school care program to meet the needs of both the student-parent and the child. Children between the ages of 5 and 10 may be enrolled in the program from 3 pm to 8 pm, Monday through Thursday. Our professional staff provides on-campus care and education according to flexible schedules that accommodate parents' needs. The program offers a multicultural environment that promotes the strength and value of human diversity.

Developmentally appropriate activities- which stimulate children's intellectual and creative abilities, enhance motor development and contribute to the acquisition of social skills are the foundation of the curriculum. Independence is encouraged by giving children the freedom to make choices.

The Child Development Center at Queens College, Inc. is a nonprofit institution licensed by the New York City Department of Health, Division of Day Care & the New York State Office of Children and Family Services Division of School-Age Child Care.

ACTIVITIES

Like many after-school programs, our program offers HOMEWORK HELP as one component of a comprehensive program. While we feel that homework help is an important element of the center's program, it is not our main focus. Our program offers activities that address children's overall developmental needs. Children need to play, have snacks, explore their surroundings, develop meaningful relationships with peers and adults, build a strong sense of self, and unwind after a long day of school. Children are provided with a LIGHT SNACK and parents are free to bring a more substantial meal for their child if they feel the child needs it. Occasionally the children will work together to prepare their own snacks. One of our classroom computers is assigned to our After School Care Program and is available to the children for work on educational projects, such as creating art work or original stories. The computer may also be available for children who need to use it to complete homework assignments, if it is not being used for classroom activity. The After-School Coordinator will determine when and how the computer will be used.

STAFF

The Center's director and teachers are early childhood educators certified by New York State. Our After-School Coordinator has experience and training in the field of education and works with children of various ages and skill levels. The Coordinator provides many engaging activities for the children. The program also consists of an Evening Program Coordinator who oversees all evening activities and a Classroom Aide who provides both classroom and administrative support.

ELIGIBILITY

Queens College student-parents may register their school-aged children who are between the ages of 5 and 10. A copy of the child's birth certificate and immunization record must be submitted at registration. The Center admits students regardless of race, creed, national or ethnic origin, and does not discriminate in the administration of its policies or programs.
